Notice of Data Collection and Use Practices: In order to administer the Essay Contest, Love City Car Ferries, Inc. will collect directly during the course of the Essay Contest the Contestant's full name, contact phone number, contact email address and the name and address of the school Contestant attends. Furthermore, the essay topic invites the Contestants to describe events in their lives, so the essay submitted by the Contestant may contain biographical information of a personal nature. The contact information is collected in order to identify the author of the essay after a blind judging process and to notify the winners of the Essay Contest. The winning essays will be published on our website and other social media will include a feature about the authors which will include additional biographical information of a personal nature (such use of winner's data hereinafter referred to as "Publishing Use"). The Official Rules also provide that as a condition of receiving the prize, the winner (or winner's parent or guardian as applicable) will be required to execute and return (a) an affidavit of eligibility and (b) a liability and publicity release, releasing Sponsor, judges and any related entities or persons from any and all claims of liability or damages arising from or relating to participation in the Essay Contest.
